Rules Governing Youth Exhibits

1. Age: The Youth department is open to boys and girls grades K-12 during the previous school year. Exception: (under ss. Ag 5.65 and 5.80) exhibitors age 5-18 entering in Department 35-Y exhibitors (Educational exhibits).
2. Junior Fair exhibitors must be members of 4-H, FFA, Scouting, or any other recognized youth organization with adult leadership and an educational program approved by the Fair Board. **Youth must be actively enrolled in the organization no later than April 1 of the current year.** Exhibitors in Educational Department (35-Y) must have been enrolled in school during the previous year.
3. A record of enrollment of all youth organizations must be filed with the Junior Fair Superintendent on or before June 1 of the current year. Enrollment must indicate project areas for each member.
4. All exhibits must be the result of the exhibitor's own labor. Department 35-Y is only for youth not enrolled in the Iron County 4-H program. Youth may exhibit only in those departments in which they are enrolled or registered. Animal entries must have been cared for, groomed and trained by the exhibitor.
5. Premiums: No exhibitor shall be paid more than 1 premium under any one lot number. No premiums will be awarded to exhibits deemed not worth by the judge. Premiums will not be paid for club parades, club floats, song contests, or a project which is not exhibited or demonstrated at the fair. Premiums will be paid directly to the exhibitor, except for group premiums which will be paid to the person identified as leader on the group entry form.
6. All exhibits must be displayed at the fair regardless of whether they are judged prior to or at the fair.
7. **All entries must be made on the official entry form. Separate forms will be used for Educational Department (35-Y) exhibits.** Exhibitor must indicate either name of school or organization name (4-H, Scouting, etc.) on entry form.
8. Danish system of judging will be used for those entered in Department 35-Y.
9. No animal or article may compete for more than 1 premium except as part of a group exhibit or in showmanship.
10. If 16 or more animals or articles are entered in any Junior Fair class, the class may be divided into 2 or more approximately equal groups according to age, weight, or other identifying characteristics and each group judged as a class.
11. In all departments in the Junior Fair Division, special classes may be established where none are specified for the item, article, or breed. State aid may be paid for the created classes in amounts equal to comparable established classes in the same department.
12. Premiums for Animal Exhibits entered by "Cloverbud" and "Explorer" members, grades K-3 will be 50% of the regular Junior Fair premium for the same class.
13. 4-H exhibitors must have completed grade 3 to exhibit any animal. Due to an insurance policy change, youth under the age of 8 or in 2nd grade or younger as of January 1 of

current year, are no longer permitted to exhibit livestock or animals at the Iron County Fair.

14. The Fair Board may request to remove an animal if it is unsafe to other people or animals.
15. **All exhibitors and animals are subject to the same regulations and requirements as in Open Division, except where specified in Junior Fair Rules.**
16. All posters shall be sized appropriate to the display, unless size is specified in the department.
17. All Youth Horse Show Exhibitors must be registered and have their horses on the fairgrounds by 8 p.m. Thursday, Aug. 4.
